

#### Institutional affiliation and administration:

- ✓ Stonewall Bridge engaged and partnered with Stonewall Community Development Corp (501 c 3)
- ✓ Conducted ongoing briefing sessions for SCDC board members on the model
- ✓ SCDC Board prioritizes Stonewall Bridge as its lead strategic priority and expands Board to support it
- ✓ Added The Stonewall Bridge onto SCDC website, with detailed links to survey, program descriptions, and research results.

### **Expert recruitment and engagement:**

- ✓ Convened 100+ stakeholders, experts and interested parties, including SCDC board, advisors, and TD bank roundtables
- ✓ With TD Bank, convened and led three national roundtables to engage 30 national experts in housing, finance, estate planning, and home and senior care

## **Technology systems:**

#### Pilot site:

- ✓ Conducted five introductory seminars, 11 private meetings, with 26 seniors
- ✓ Conducted two online surveys (introductory and needs assessment)
- ✓ Held individual meetings with several interested seniors to identify early adopters open to use home monitoring system, consider home equity commitments
- ✓ Several residents have indicated willingness to donate homes or home equity
- ✓ Identified local expertise in senior care, property management and financial resources
